WHY THE FOUNDATION?

Ten years ago, 1,300 past pupils celebrated the 50th anniversary of Henderson High School. It was clear that there was an abiding interest in the on-going affairs of the school. The Past Pupils Association grew out of that interest. There has also been a growing desire to invest more directly and materially in the school today. Many secondary schools around New Zealand have benefited significantly from past pupil support.

For our initial project, the Henderson High School Board of Trustees and Principal Mike Purcell, have identified a tract of land formerly bordered by C and N blocks, as an area they wish to develop as the 'heart of the school'. If you've visited the school over the Jubilee weekend, you will have seen the open area at the centre of the campus.

The plan is to transform this space into a quadrangle that reflects the school's culture and heritage.

An initial Foundation target of \$100,000 would fund the first stage of this project, funds remaining would be invested to accrue interest for other projects and purposes.
